# THE RUSS PARR JOBS ACT CONTEST OFFICIAL CONTEST RULES

## **CONTEST DESCRIPTION:**

The Russ Parr Jobs Act Contest ("Contest") will begin on Monday, October 10, 2011 at 6:00 am EST and end on Friday, November 11, 2011 at 10am EST ("Contest Period"). The job of being a loyal Russ Parr Morning Show listener has only one requirement; that you listen to the Russ Parr Morning Show every day. Now Russ is paying his loyal listeners for a job well done. In order to get the cash, loyal listeners must pass a simple job performance evaluation and answer an easy question about the show. A correct answer wins \$100. An incorrect answer gets the listener suspended, fired or written up for the rest of the day without pay.

Every morning, every hour, for the duration of the Contest Period, The Russ Parr Morning Show, will award \$100 to contest winners.

## **HOW TO ENTER:**

Listeners of The Russ Parr Morning Show (also "RPMS") who are legal residents of the 48 contiguous United States (excluding Rhode Island) and are 18 years of age or older will be able to take part in this Contest. To participate in the Contest, listeners must do the following:

- 1. Listen to the Russ Parr Morning Show weekday mornings (Monday through Friday) from October 10, 2011 November 11, 2011 between 6:00am ET 10:00am ET.
- 2. The Russ Parr Morning Show will solicit for the 19th caller once every hour each weekday morning. Listeners can qualify to participate in the contest and win \$100 by becoming caller nineteen (19) at 1-877-PARR-Sho (1-877-727-7746) after hearing the on-air solicitation for callers. WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. Contest participants should not rely on streamed broadcasts to participate in the Contest.
- 3. The Russ Parr Morning Show will ask the 19th caller a question about the show. If the caller answers correctly, he / she will win \$100. If the caller answers the question incorrectly, he / she will "be suspended, fired or written up for the rest of the day without pay" and will not win the \$100, and the Russ Parr Morning Show will repeat the contest again during that hour until the \$100 is awarded.

## **ELIGIBILITY RESTRICTIONS:**

- 1. The Contest is open to listeners of the RPMS who are legal residents of the 48 contiguous United States (excluding Rhode Island) and are 18 years of age and older.

Rapids, NC; WIZF-FM, Cincinnati, OH; WHHH-FM, Indianapolis, IN; WQOK-FM, Raleigh, NC; WCDX-FM, Richmond, VA; WKYS-FM, Washington, DC; WJKS-FM, Philadelphia, PA; WZFX-FM, Fayetteville, NC; WNOV-AM, Milwaukee WI; WGZB-FM, Louisville, KY; WDHT-FM, Dayton, OH; WXBT-FM, Columbia, SC; KZRB-FM, Texarkana, TX; Shreveport, TX; KBXT-FM, Waco TX; WQBT-FM, Savannah, GA; KZEY-AM, Tyler, TX; WIIZ-FM, Augusta, GA; WJWZ-FM, Montgomery, AL; KNDA-FM, Corpus Christi, TX; KMRK-FM, Odessa, TX; WZLD-FM, Hattiesburg, MS; (the "Participating Stations"), their respective officers, directors, subsidiaries, affiliates, advertisers, general sponsors, promotional partners, members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and those living in the same household (whether related or not) of any of the above are NOT eligible to participate or win in this Contest.

- 3. If any selected winner is under the age of eighteen (18) or resides outside of the continental United States (or in Rhode Island), they will be disqualified.
- 4. RPMS and Radio One (together "Company") assume no responsibility for any computer, telephone, cable, network, electronic or internet hardware or software malfunctions, failures, connections, availability, traffic congestion, unauthorized human intervention, or any other type of error or malfunction that may prohibit a contestant's ability to participate in the promotion.
- 5. Once an individual wins a prize in <u>this</u> Contest, they are not eligible to win another prize in <u>this</u> Contest except as specified within these rules.
- 6. Persons who have won a prize in another contest or promotion of any kind from RPMS within the thirty-day (30) period immediately preceding the start date of this Contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from RPMS during any thirty (30) day period.

#### PRIZES:

- 1. One Hundred Dollars (\$100) will be awarded to each winner.
- 2. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by Company in its sole discretion.
- 3. All contest winners must sign and date official release and waiver forms as requested. Failure to do so will result in winner forfeiting the prize.
- 4. All cash prizes won will be awarded in the form of a check. Prize check will be mailed to the winner via certified mail upon receipt of a signed release form with a copy of the winner's government-issued photo I.D.
- 5. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner will be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of Company if another contestant is to be selected as the winner if time permits.

- 6. Prizes will be awarded only upon winner verification and final approval by Company. Each winner or selected entrant will be notified by email, mail and/or phone within ten (10) days after being selected (e.g., date of drawing). Each winner or selected entrant will then have ten (10) days to respond with their information. If the winner or selected entrant is unable to be contacted within ten (10) days after being selected (e.g. drawing date), is ineligible, fails to claim a prize or fails to return completed and executed release forms and affidavits, if applicable and as required by Company, or if the prize notification or prize is returned undeliverable, that prize will be forfeited and if time permits, at the discretion of Company, an alternate entrant will be selected as the winner by random drawing from among the remaining entries.
- 7. Winners must provide valid identification (i.e. via driver's license, passport or other government-issued photo I.D.) to claim their prize. .

#### **EXECUTION:**

- 1. During the Contest Period, The Russ Parr Morning Show will solicit eligible listeners to be the 19th caller once every hour each weekday morning. Listeners can qualify to participate in the Contest and win \$100 by becoming caller nineteen (19) at 1-877-PARR-Sho (1-877-727-7746) after hearing the on-air solicitation for callers.
- 2. The Russ Parr Morning Show will ask the 19th caller a question about the show. If the caller answers correctly, he / she will win \$100. At the time of the call, the winner will be asked to provide their contact information (off the air); name, address, phone number, and email address.
- 3. If the caller answers the question incorrectly, he / she will "be suspended, fired or written up for the rest of the day without pay" and will not win the \$100; and the Russ Parr Morning Show will repeat the contest again during that hour until the \$100 is awarded.
- 4. Prize checks will be mailed to winners after all requested release forms have been received.
- 5. All decisions made by Company regarding any aspect of this Contest are final.

#### **GENERAL CONDITIONS:**

- 1. Winners are responsible for all applicable taxes associated with the receipt of the prize (prizes are not transferable and may not be exchanged).
- 2. Any person winning over \$600.00 in prizes will receive an IRS form 1099 at the end of the calendar year for tax purposes and a copy of such form will be filed with the IRS as required by law.
- 3. No purchase necessary. Contest is void where prohibited. Contest is subject to all applicable federal, state, local laws and regulations.
- 4. Odds of winning depend upon the number of eligible contestants participating during the Contest Period.

- 5. By participating in the Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest, in any media now known or hereafter devised for advertising or promotional purposes without additional compensation, and must sign a publicity release prior to acceptance of the prize. By entering this Contest, each participant agrees to comply with these Official Contest Rules and the decisions of The Russ Parr Morning Show and or Contest sponsor which shall be final and binding in all aspects relating to the Contest.
- 6. Company retains the right to disqualify any contestant if all Contest rules are not followed.
- 7. All Contest winners will be required to sign a liability release prior to acceptance of any prize. Pursuant to the liability release, the winner or winners will agree to hold Company, any other Contest parties and each of their respective affiliates, subsidiaries, agencies, officers, shareholders, directors, employees, agents and representatives of each of the foregoing, harmless against any and all claims or liability, directly or indirectly related to or arising from or in connection with Contest participation or the acceptance, possession or use / misuse of any awarded prize or any portion thereof, or participation in prize-related activities, including but not limited to any related travel.

By accepting the prize, the winner acknowledges that Company has neither made, nor is in any manner responsible or liable for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize or to any portion thereof, including but not limited to its quality, mechanical condition or fitness for a particular purpose.
- 9. Dates and times of concerts, events, and trips promoted by Contest sponsors are subject to change and those changes are deemed to be beyond the control of Company. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. Company is not obligated to make any effort to find an alternative prize under these circumstances.
- 10. Company, the Participating Stations, participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for the inability of any contestant to complete or continue an internet registration due to equipment malfunction, busy lines, inadvertent disconnections. unavailable network, server, Internet Service Provider (ISP) or other connections, communication failures or human error that may occur in the transmission, receipt or processing of entries, including any injury or damage to any computer arising from or relating to participation in this Promotion. Any use of robotic, macro, automatic, programmed or like entry methods will void all such entries, and may subject that entrant to disqualification. Any attempt by an entrant to deliberately undermine the legitimate operation of the Contest may be in violation of criminal and civil laws and should such an attempt be made, Company reserves the right to seek remedies and damages (including attorney's fees) from any such entrant to the fullest extent of the law, including criminal prosecution.
